### B. HS SEL

- 1. SEL planning for the rest of 23-24 (Legg/ Rodriguez)- 3 Min
  - a) Ensure dedicated time for seniors to complete ICAP and dedicated time for senior messaging
  - b) Rodriguez Public Comment
    - (1) Frustrated with inconsistency of schedules
    - (2) Decline of senior participation this year
    - (3) FAFSA deadline has been changed by government (shift from legislation to simplify form)- This year 40 students have submitted vs 90 from last year
    - (4) Goal is to increase college enrollment by 3%
    - (5) Proposed Request: Consistency of date, updates to scheduling if changed, etc, and for teachers
    - (6) Proposed Solution: Rodriguez has reached out to other DSF to see how other schools implement schedules
  - c) Legg Public Comment
    - (1) Does not want SEL to be the time to complete ICAP

- (a) Important for graduation, but simple
- (b) Hope it is a time for students to reflect on importance of what they are doing now
- (c) Uncomfortable with this year's schedule and assigning grades to the amount of time spent with Students
- (d) Proposed Solution: Would be willing to help a team in June to create plans for next year
- d) Semester Dates: March 22, April 5, May 10
  - (1) Seniors can have ICAP and SEL block on 3/22
    - (a) Seniors can have alternate schedule- Legg will work with Bissell
  - (2) 3/22 is a full day. Schedule coming soon.
- e) SEL is a state Requirement
- f) April 17 will be a Senior Support Day
- 2. SEL planning for 24-25 SY
  - a) Start and End Times for 24-25 SY have been determined and cannot change
  - b) Cannot do HS SEL schedule like MS, because there are not enough content classes
  - c) Feedback from constituents
    - (1) English: 1 response saying they do not care what schedule is, want time to plan ahead
    - (2) DCTA, Science,: Several responses to add a 20 min extension to a class
      - (a) Challenges for mixed grade levels, off periods, teachers with large class sizes, we have tried this before and teachers used the extra time for ext class
      - (b) Ext time could be time for announcements, more time to build relationships
      - (c) Feedback from DCTA: Don't like current schedule, or make it simpler
      - (d) Teachers need to follow schedule set so we don't lose fidelity
    - (3) Math: some want 2x a week (T, TH), some okay with schedule now
    - (4) SS: Change messaging and culture that teachers need to implement, kids do not have buy-in to SEL. Need to shift culture.
    - (5) Weekly 30 min check-in
  - d) Requesting approval for a committee to be established to develop an SEL plan for next year that will be subject to approval from SGB. (Legg)
